

Delay of Enforcement of the Silica Standard for Construction

OSHA will delay enforcement of the respirable crystalline silica standard for construction until September 23, 2017, to conduct additional outreach and provide educational materials and guidance for employers.

The final rule on Occupational Exposure to Crystalline Silica in Construction, published on March 25, 2016, established a new Permissible Exposure Limit and contained several other ancillary provisions that apply to the construction industry. This rule was codified at 29 CFR § 1926.1153 and became effective on June 23, 2016. Under the standard, all obligations were to commence on June 23, 2017, except for requirements for sample analysis in paragraph (d)(2)(v), which commence on June 23,2018.




The construction standard for crystalline silica has a number of unique features warranting development of additional guidance materials. In order to provide the opportunity to conduct additional outreach to the regulated community and to provide additional time to train compliance officers, OSHA has decided to delay enforcement of this standard until September 23, 2017.

Northeast Indiana Regional Development Authority Recommends Funding for Seven Projects

The Northeast Indiana Regional Development Authority (RDA) met earlier in the month to consider requests for Regional Cities Initiative funding for projects supporting the Road to One Million plan.

Due to supplemental funding resources to support The Landing development in Fort Wayne, the board has an additional \$2 million to invest in regionally transformative projects. To be able to fund as many projects as possible, the RDA reduced each project's original grant request by 2 percent.

The board voted to support seven projects including:

- Riverfront Park Fort Wayne Phase I in Allen County, which endorsed a \$5,170,480 grant, representing less than 20 percent of the \$26,381,000 of the project's total cost;
- Eagles Theatre Project in Wabash County, which endorsed a \$976,635 grant, representing less than 20 percent of the \$4,982,838 of the project's total cost:
- 3. Wabash Trails in Wabash County, which endorsed a \$941,031 grant, representing less than 20 percent of the \$4,801,180 of the project's total cost:
- Russel and Evelyn Fahl Aquatics Facility in Whitley County, which endorsed a \$844,078 grant, representing less than 20 percent of the \$4,258,751 of the project's total cost;
- 5. Strawberry Valley Cultural Trail in Noble County, which endorsed a \$248,920 grant, representing less than 20 percent of the \$1,270,175 of the project's total cost:
- 6. Fishing Line Trail in Noble County, which endorsed a \$171,500 grant, representing less than 20 percent of the \$1,023,673 of the project's total cost; and
- 7. Kendallville Outdoor Recreation Center in Noble County, which endorsed a \$392,000 grant, representing less than 20 percent of the \$2,388,132 of the project's total cost.

"For the RDA board, it's critical we fund as many regionally transformative projects as possible to attract and retain talent in Northeast Indiana. Thanks to the funding available to The Landing Project, we were able to invest in seven more quality of place projects across the region. This is what the Road the One Million plan is all about," said RDA board chair Bob Marshall, executive vice president of Campbell & Fetter Bank.

The Board's recommendation now goes to the Indiana Economic Development



IEDC Approves Regional Cities Funding

Indiana Economic Development Corp. has approved a total of nearly \$8 million in Regional Cities Initiative funding for three projects in northeast Indiana. The projects will take place in Shipshewana, Fort Wayne and Huntington.

The IEDC approved \$3.8 million in funding for the relocation and expansion of the Michiana Event Center, which has previously operated in Howe and will move to Shipshewana. The IEDC says the project, which totals \$19 million, will enhance tourism in the region.

An additional \$2.48 million in funding has been approved for the Posterity Scholar House on the southeast side of Fort Wayne. The project aims to provide affordable housing to lower-income or single-parent families looking to obtain post-secondary education. It will connect single-parent students with opportunities in various growth sectors in the region, including advanced manufacturing and healthcare.

Construction on the nearly \$12.5 million project is expected to be complete in 2018. Finally, the IEDC has approved \$1.6 million in funding for the UB Block in Huntington, which consists of three historic buildings to which Huntington University plans to move and expand programs in entrepreneurship and economic and civic collaboration. The IEDC says Pathfinder services will also relocate and expand its Creative Abilities Art Center in the UB Block. Construction is expected to be complete by August 2018.

"Indiana has built a great business environment through deliberate planning, sound fiscal polices and a collaborative effort to create long-term solutions for economic growth and prosperity," said Indiana Secretary of Commerce Jim Schellinger.


