### **OSHA 29 CFR 1926.50 (c): Medical Services and First Aid**

In the absence of an infirmary, clinic, hospital, or physician, that is reasonably accessible in terms of time and distance to the worksite, which is available for the treatment of injured employees, a person who has a valid certificate in first-aid training from the U.S. Bureau of Mines, the American Red Cross, or equivalent training that can be verified by documentary evidence, shall be available at the worksite to render first aid.

Upon successful completion, each participant will be issued a course completion card from the American Safety & Health Institute valid for two (2) years.
